**2. Functions:**

The functions of the Punjab State Bet Areas Advisory Council shall be as follows:-

- (i) to define the Bet Areas of the State ;
- (ii) to aid and advise the Government in drawing up schemes and programmes for the development of these areas;
- (iii) to undertake area planning of these areas in order to ensure integrated and all around development of these areas;
- (iii) to fix the priorities of various development works to be executed in these areas;
- (iv) to co-ordinate and review the activities of the various departments with a view to remove the bottlenecks and difficulties in the speedy implementation of the programme;
- (v) to take effective steps for spreading literacy in these areas; and
- (vi) to devise measures to raise the standard of living of the backward sections, landless labourers and agricultural workers in these areas.

**4. Headquarters:**

The headquarters of the Council shall be at Chandigarh.

**5. Terms and conditions regulating TA/DA of the members shall be as under:-**

- (a) The MLA's will draw Travelling Allowance/ Daily Allowance as admissible to them as Members of the Punjab Vidhan Sabha.
- (b) "The Traveling Allowance admissible to members of Parliament will, in respect of journeys performed by rail, be the same as is admissible to the Members of the State Legislature appointed in an ex officio capacity.
- (c) The official members will draw TA/DA as admissible to them under the TA Rules.
- (d) The TA bills of the ex officio MPs/ MLA will be prepared/ countersigned by the Under Secretary (Accounts), Punjab Civil Secretariat. The Secretary, Punjab Vidhan Sabha will, however, verify the TA claims of the MLAs to the effect that no TA in respect of the journey or DA for the period mentioned in the bills has been claimed by the member concerned from any other official source.

- (e) The expenditure involved shall be met out of the Budget Head"2052- Secretariat General Administration-090- Secretariate-04 General Services Secretariat (05)- Travel Expenses TA/DA to non official members.
