2. In continuation of this Department letter No. LPD/Allocation/BDI/2006/2351 dated 1.3.2006, the Governor of Punjab is pleased to allocate an additional amount of Rs. 37.94 crore (Rs. Thirty seven crore and ninety four lakh) for 'Punjab Nirman Programme' under the Plan Scheme PM 1.5 'Formulation of district plan at District Headquarter' from the overall plan savings during the current year 2005-06 and to release the funds for 1897 unanimously elected panchyats @ Rs.2.00 lakh per panchayat as per detail given in Annexure-I. The list of unanimously elected panchayats has already been sent to the Deputy Commissioners- cum-Member Secretaries, District Planning and Development Boards by the Department of Rural Development and Panchayats, Punjab vide its letter No. DPP-6-2006/122-138 dated 15.2.2006.

3. This issues with the concurrence of the Finance Department's I.D.No.3/68/05-1 FE-6/1155 dated 28.3.06. .

4. The expenditure may be incurred under the Capital Head "5475- Capital outlay on other General Economic Services-01-District Plan at the district headquarters-112 Statistics.

5. It will be the responsibility of the concerned Gram Panchayats to ensure that funds are drawn from the Government Treasury as per the actual requirement.

6. These funds are to be used only and only for the purpose for which these have been released and no deviation from the specified purpose be allowed.

7. Reconciliation of the above expenditure with the A.G., Punjab may be ensured.

8. Utilization Certificates may be obtained from the concerned Gram Panchayats at the earliest possible.
